# **Proceedings of the 52<sup>nd</sup> Annual General Body Meeting of the Institution of Agricultural Technologists, Bengaluru for the 2023-24 held on Wednesday the 18-12-2024 at 3 P.M. at Dr. H.R. Arakeri Auditorium of the Institution of Agricultural Technologists, Bengaluru**

## **(1) Welcome :**

Sri. V.K. Kamatar, the Secretary heartily extended a warm welcome to the President, Vice Presidents, Joint Secretary, Treasurer, all the members of the Managing Committee, the beloved members of IAT who are present and requested the President Smt.C.N.Nandini Kumari to preside and conduct the meeting.

The President Smt.C.N.Nandini Kumari also welcomed warmly one and all. The total members present was only 206. As there was no quorum i.e. 1/10 of the total members as per bye-law shead journed the meeting for the next 30 minutes. The members again reassembled after half an hour. As there was no change in the attendance and no quorum is needed for the adjourned meeting the President Smt.C.N.Nandini kumari declared the Annual General Meeting open and authorized the Secretary to proceed as per the agenda of the notice.

The members as per practice in the standing position observed one minute silence in reverence to the departed above members of the IAT and ending with reciting “OM SHANTHI”.

**3) To read the notice calling for the 52<sup>nd</sup> Annual General Body Meeting of the Institution**

The notice dated 21-11-2024 which has been sent to all the life members already by post to their address was read out by the Secretary.

**4) Confirmation of the minutes of the 51<sup>st</sup> Annual General Body Meeting held on 18-12-2023 and action taken.**

Detailed and very exhaustive discussions were held based on each paragraph-wise and item-wise points as printed in Page Nos 5 to 9 of the AGM booklet circulated to all the members.

- 1) Action taken on the suggestions given in the 51<sup>st</sup> AGM held on 18-12-2023. The Secretary readout and explained in detail as printed in the booklet on pages 10 to 12 regarding the action taken on the suggestions given in the previous AGM.
- (i) **Online voting:** The Secretary explained and readout in detail as listed the difficulties, drawbacks in the same and to adopt the basic requirement needed by the members to opt for the system. They also suggested that online voting, quota of members region-wise, district-wise representatives elected, the advantage or otherwise if the system is adopted was discussed.

Sri. R. Ramamurthy, Sri.S.H.Hanumantharaya Reddy, Prof.V.Veerabhadraiah, Dr.G.Eswarappa, Sri.S.M. Desai, Sri.G.Rangaswamy and Sri.P.D.Jatti offered their suggestions, drawbacks of the system. The Secretary replied in the light of the opinions just given this may be considered in the next Managing Committee meeting/ byelaw amendment meeting.

Sri. E. Jayarama Reddy, Prof.V.Veerabhadraiah, Dr.G.Eswarappa, Sri.P.D.Jatti and Sri.G.T.Veerabhadra Reddy discussed and participated in the replies readout by the Secretary as printed and offered their opinion in the matter.

The proposal to change the logo of IAT was deferred by the AGM.



Finally, the action taken and minutes of the meeting and the suggestions given *i.e.* Sl.No.1 to 10 were proposed for acceptance by Dr.G.Eswarappa and seconded by Sri.R.Ramamurthy for confirmation and approval. The General Body then unanimously approved the proceedings including the action taken report as given on page 5 to 12.

Intervening in the discussion Prof.V.Veerabhadraiah happily informed that Sri.B.N.Aswathanrayana, former Treasurer, IAT is helping the IAT by his presence and attendance in the institution in many ways sincerely and with interest and updated several records to the appreciation of the members and Managing Committee and this needs to be documented in the AGM and profusely thanked him for his efforts with a great applause by one and all present.

**(5) Presentation and adoption of the Annual Report of the activities for the period ending March 2024.**

The Secretary presented and explained the highlights of the annual report of the activities for the year 2023-24 including that of the Regional Chapters as printed in the booklet on pages 12 to 27. To a question by Sri.M.G.Vedamurthy from Shivamogga Regional Chapter the Secretary stated that the Krishi Ankura programme will be included and continued in future also. Members suggested to approach the Income Tax authorities and obtain 80 G exemption as early as possible. The AGM discussed regarding the programmes done, lot of Initiation taken by Sri.S.M.Sidda Reddy at the Regional Chapter Raichur in conducting programmes, adoption of villages, school and Sri.R.A.Patil, then member and presently President of IAT Raichur Regional Chapter informed it will not be a surprise if Regional Chapter Raichur becomes shortly a model Regional Chapter and all the aims of IAT will be fulfilled .

Prof. V. Veerabhadraiah told to implement /publish the newsletter in future in time still more attractively but also quarterly and also annually once atleast and try whether it can be digitalized and published to save expenditure.

After the above discussion on the subject Sri.G.T.Veerabhadra Reddy proposed and Sri.M.Shankarappa seconded for approval and the General Body unanimously approved and adopted the report of the activities for the period ending March 2024.

**(6) To present and to adopt the Audited Statement of Accounts, Annual Balance Sheet and also Income and Expenditure account as on 31<sup>st</sup> March 2024.**

The Treasurer Sri. B. Umesh presented the annual audited report/ statement pertaining to the Balance sheet, Income and Expenditure as on 31-03-2024 as furnished on pages 28 to 38 and requested for adoption and approval of the same.

The Treasurer explained the important items in the report and figures pagewise and sought the approval. Prof.V.Veerabhadraiah pointed out that the rent for the building is not received as could be seen and requested for early action to recover the rent from M/s.St.Xaviers Educational and Charitable Trust by taking action as it is deemed fit in the interest of the IAT.

To a proposal to merge the long pending APWSS funds lying idle after lengthy discussions the AGM unanimously agreed not to merge the funds with IAT general fund but to use the same to conduct weed science and plant protection related programmes in the Regional Chapters level also.

Dr. G. Eswarappa suggested in this regard the Treasurer should also give item-wise Income & Expenditure under each programme of work for the information of the members.

The members being satisfied, Sri.E.Jayarama Reddy, proposed and Mr.S.H.Hanumantharaya Reddy seconded for the approval.



The general body then unanimously considered and approved the report.

### **Ratification of Expenditure incurred by the Managing Committee during 2023-24 exceeding the powers of the Managing Committee.**

The Treasurer readout the above statement as furnished on page 39 and suggested for ratification by the Annual General Body.

The Annual General Body members present suggested that the ratification of the expenditure incurred to pay the statutory taxes as per procedure and law like property tax, lease amount, income tax, GST, etc. and such items need no ratification by AGM and the rest of the expenditure incurred was unanimously accorded the approval.

### **Further AGM is also approved for getting 80(G) registration with the Income Tax department to get more CSR grants from the Corporations, Companies and such other organizations.**

Sri. Venkataramana, K. suggested to plan to purchase or get allotted a C.A. site to IAT and shift the IAT as C.A.sites are allotted in new layouts by the concerned authorities to institutions and hence his suggestion.

### **(7) To approve the proposed Budget for the year 2025-26**

The Treasurer Sri. B. Umesh presented the proposed budget as furnished on page 40 and 41 and suggested the approval after explaining some of the important facts and figures.

Dr. G. Eswarappa intervened in the discussion and pointed out that the Shivamogga Regional Chapter should immediately fence the site, erect a suitable board at the proposed site and also to take action to overcome and settle all the hurdles, if any in the matter.

The Secretary explained that the proposals for the next year has been presented today in advance by Treasurer as per bye-law.

Sri. K. Badappa proposed for approval and Sri.B.N.Aswathanarayana seconded for approval and then the AGM unanimously approved the same.

### **(8) To appoint Auditors to audit the accounts for the year 2024-25 and fix their remuneration**

The Secretary and Treasurer proposed for the continuation of the present auditors M/s.M.A. Narasimhan and Co, Chartered Accountants, Bangalore and also justified the proposal. It was proposed by Mr.Siddaraju and seconded by Sri.R.Ramamurthy. The August General Body unanimously approved and authorized the Managing Committee to pay a reasonable remuneration to the auditors based on the quantum of work involved.

### **(9) To consider written proposal if any received by the Secretary**

The Secretary informed that four written proposals were received in the stipulated time and the same was discussed in the Managing Committee and replied are as follows :

#### **a) Sri. H.S. Krishnamurthy, Mysore**

To a question regarding the approval of the proposed budget it was explained that in the 51<sup>st</sup> AGM held for the year 2022-23 on 18-12-2023 the proposed budget for the year 2024-25 has been placed and got approved and in the 52<sup>nd</sup> AGM held today the proposed budget for the year 2025-26 was included for approval in advance as per the bye-law and is already approved now in the meeting earlier.

#### **b) Dr. B.V. Shivamurthy, Mysore and Dr.M.A.Shankar, Bengaluru.**

This is regarding to implement online voting system / electronic voting system in the IAT elections. The Secretary replied already this is under discussion in the IAT Managing Committee/ Bye-law amendment sub-committee and all the advantages/ disadvantages and the requirement to implement



the same is under very active discussion. It is already discussed earlier today in the beginning as narrated under action taken in Sl.No.4 of this proceedings and the replies are already accepted by the AGM and the same is valid here also for the present.

**c) Sri. R. Ramamurthy, Bengaluru**

The matter in the letter on all the points was read, highlighted and discussed and a few senior members also offered their opinion in the matter. Finally it is suggested that Sri.R.Ramamurthy may himself as a senior member and also the previous Secretary was requested to send a draft proposal / resolution to the IAT later on and it will be considered by Managing Committee in future for necessary action, if found useful.

**d) Sri. G.S.Iyengar (I-008/2508)**

Suggested through his letter dated 5-12-2024 that IAT to take up in helping to mitigate the climate changes, rural youth migration etc. of glaring unnatural abnormal events by creating awareness on growing perennial income yielding useful trees for getting income to farmers and also to encourage for establishing small scale industries/ start-ups etc, to stop migration of local youths to urban areas. For this suggestion AGM applauded and accepted whole heartedly the suggestion given by the Senior most IATian.

At the end the AGM unanimously accepted all the replies as given above.

**(10) Any other subject with the permission of the chair.**

The Secretary placed before the AGM, august body, regarding vacating the present tenant in the N.Chikkegowda Block building occupied presently by St.Xavier Educational and Charitable Trust on account of not paying the rent as per agreement since June 2023. The matter which is unsettled still and explained in detail the complete action taken in the matter so far step by step and the next proposed also i.e. vacating notice, legal action, police action, cheque bouncing, Sri.Bharatlal Meena's suggestions, opinion and consultation etc. and the matter is not yet settled and the heavy court fees also has to be remitted in the matter etc.

Very senior members present had a very lengthy fruitful discussion and gave their suggestions and opinions in the matter.

Finally, the AGM, august gathering, approved the action initiated so far by the Managing Committee and authorized the payment of the court fee also if it is necessary, constitute a special sub-committee for this with all senior selected experienced members and former Managing Committee members also if needed and take the opinion and proceed further that is deemed fit. As per the request of the Secretary some of the senior members present accepted to join the sub-committee, if constituted.

The AGM authorized fully the Managing Committee in the matter and to take the legal opinion at each step and file the eviction suit in the court at the earliest.

**11) Address by the President**

The President in her very brief address thanked all the M.C. members, life members for their valuable suggestions, co-operation, support, very lively participation in the todays meeting and assured that the opinion, valuable suggestions given will be taken for action in future in the remaining period.

She also thanked all the office bearers, office staff for their excellent cooperation in conducting the AGM.



## 12) Vote of thanks

On behalf of the life members present Sri.B.N.Aswthanarayana thanked profusely the President and other office bearers for having conducted the AGM in a very lively, fruitful manner and stated the present President is the first woman President in the history of IAT and for her donation of Rs.2.00 lakhs to the IAT also and offered a flower bouquet as a token of appreciation.

Dr. B. Krishnamurthy, Joint Secretary proposed finally the vote of thanks to the chair, office bearers, Managing Committee members, life members and office staff for their co-operation, active participation and valuable opinion and suggestions given for conducting the AGM smoothly without any hassle.

The President declared that the AGM is closed.

## **Part I. Activities in General**

- a) The Governing Body of the Institution shall be the Managing Committee(M.C.). The administration and Management of the Institution shall vest with the Managing Committee consisting of 15 elected members, two co-opted members, four representatives nominated co-opted from four Regional Chapters on yearly rotation basis and 15 ex-officio members. The elected members from among themselves choose the President, two Vice-Presidents, Secretary, Joint Secretary and Treasurer as office bearers.
- b) The Managing Committee is supported with 9 sub- committees for easy implementation of various activities/ programmes. The Managing Committee meets every month regularly to review the activities implemented by different sub-committees and extend required support / guidance. The activities planned by different sub-committees have been carried out effectively. Monthly and cumulative yearly Income and Expenditures were reviewed on monthly basis. Regular Managing Committee meetings were conducted both physically and virtually. During the year 2024-25 a total of - 12 Regular Managing Committee meetings and seven special meetings of Managing Committee were also conducted.
- c) In addition to Central Committee at Bengaluru, IAT has formed 20 Regional Chapters at different districts. Regional Chapters are supported with Financial assistance to conduct different activities. The Center has also supported the Regional Chapters like Chitradurga, Davanagere, Vijayapura, Belagavi, Shivamogga and Mysuru to procure sites and construct buildings for the use and benefit of the respective chapters.
- d) **52<sup>nd</sup> Annual General Body Meeting of IAT Bengaluru for the year 2023-24 held on 18.12.2024**  
AGM confirmed the minutes of the 51<sup>st</sup> AGM meeting held on 18.12.2023, considered and adopted
  - (1) Annual activities report for the period ending March 2024.
  - (2) Annual balance sheet, Income and Expenditure account as on 31<sup>st</sup> march 2024
  - (3) Approved the budget proposal for the year 2025-26.
  - (4) Approved to appoint auditors for the year 2024-25.
  - (5) Ratified the expenditure incurred by the M.C during the year 2023-24, exceeding the powers of managing committee.

## **Part II. Activities Report of Central IAT Bengaluru**

The Chairpersons of different sub-committees of the Institution have implemented various programmes, workshops, brainstorming/Interaction Sessions and on areas related to education, personality development, health, cultural etc. for the benefit of members, families and farmers. #### (3) Agribusiness Consultancy Services : Chairperson Sri.Venkataramreddy J. Patil

During the year 2024-25 the committee was responsible to complete two projects to IAT from Karnataka Monitoring and Evaluation Authority. The projects are

1. “Improving the productivity of Pigeonpea (TUR) in Karnataka with District and Taluka wise scientific analysis” with a project cost of Rs. 5.0 lakh. The project was headed by Dr. Raju G. Teggelli EC member and senior scientist KVK Kalburgi. It envisages to undertake area, production and productivity trend analysis, find out the causes for low productivity in different regions and suggest the suitable measures to improve the productivity based on survey cum research approaches. The study was completed and final copies were submitted.
2. “Evaluation of Special Component Plan (SCP) and Tribal Sub Plan (TSP) Interventions of Chief Minister’s Sookshma Neeravari Yojane, New Crop Insurance Scheme: Pradhan Mantri Fasal Bima Yojana (PMFBY), Farm Mechanization, Polyhouse Scheme and Incentives for Milk Producers from 2017-18 To 2019-20 on Socio-Economic Status of Farmers in Karnataka” with a project cost of Rs. 75.0 lakh, and headed by Dr. N. Devakumar EC co-opted member and former Director of Extension. The evaluation of five schemes implemented by Department of Agriculture, Horticulture and Veterinary and Animal Husbandry Services. The study area comprises of 10 districts in each Agro-climatic zones of the state and it is progress.

The study was conducted in all the 10 AgroClimatic Zones of the state for all the five schemes. The final draft report is approved and preparing to submit the final corrected report.



#### **(4) Regional Chapter development and enrolment of members :Chairperson- Sri.L.I. Roodagi**

During the year 2024-25, 67 new life members were added, raising the total strength to 5876. Efforts were made through the members, Regional Chapters and officers of all the development Departments and Universities for enrolling members to IAT.

The Regional Chapters have been supported regularly to carryout their activities.

S. Patil, MC Member, IAT Bengaluru; and Dr. S. M. Vastrad, Senior Scientist and Head, KVK Vijayapura.
